#### **Information for Residency Classification**

- A Florida resident for tuition purposes is a person who has, or a dependent person whose parent or legal guardian has, established and maintained legal residency in Florida for at least 12 consecutive
  months preceding the first day of classes of the term for which Florida residency is sought. Residence in Florida must be as a domicile rather than for the purpose of maintaining a residence incident to
  enrollment at an institution of higher education.
- To qualify as a Florida resident for tuition purposes, you must be a U.S. citizen, permanent resident alien or legal alien granted indefinite stay by the U.S. Citizenship and Immigration Services. Other persons not meeting the 12 month legal residence requirement may be classified as Florida residents for tuition purposes only if they fall within one of the limited special categories authorized by the Florida Legislature and the State Board of Education. All other persons are ineligible for classification as a Florida resident for tuition purposes.
- Living in or attending school in Florida will not, in itself, establish legal residence. Students who depend on out-of-state parents for support are presumed to be legal residents of the same state as their parents. Residence for tuition purposes requires the establishment of legal ties to the state of Florida. Students must verify that they have broken ties to other states if the student or, in the case for dependent students, his or her parent, has moved from another state.

Dependent: a person, whether or not living with his or her parent, who is eligible to be claimed by his or her parent as a dependent under the federal income tax code.

Independent: a person who is at least 24 years old, married, a veteran, a member of the armed forces, an orphan, a ward of the court, or someone with legal dependents other than a spouse, per the U.S. Department of Education for the purposes of federal aid eligibility. There may be limited cases where a person under the age of 24 years old may qualify as an independent student. Such students will be required to verify independence.

#### Overview of Financial Aid at Marion Technical College (2017-2018)

The following is a brief overview of the financial aid programs available here at Marion Technical College. A complete Policy & Procedures manual is available in the financial aid office. Financial aid information, forms & applications also available on our website @ www.MarionTC.edu

**Federal Pell Grant** - permits an eligible student to receive up to \$5,920.00 (2017-2018) per academic year to cover educational expenses on eligible programs. These are awarded on a graduated scale according to an (EFC) estimated family contribution. A FSA ID username and password is necessary for both student and parent if dependent, to login and complete the FAFSA application for a federal Pell Grant. This can be obtained @ www.fafsa.gov. List us as a school of interest to determine eligibility. **Our school code is 031039**. Follow up with the financial aid office 3-5 days after your application has been processed. Students will be notified of the estimated Federal dollar amount that they are eligible to receive. A full Pell award is based on a 900 clock hour program. The Disbursement award for the year will be split into payment periods of 450 clock hours or as otherwise stated in the student's award letter based on program hours.

The Federal Supplemental Educational Opportunity Grant (FSEOG) - may provide additional grant money to a student's financial aid package if financial need is demonstrated. Unlike Pell Grants, the amount of this grant depends not only on financial need but on other aid sources and the availability of funds allocated to the school. To be considered, the student must be a United States Citizen or eligible noncitizen, not have obtained a bachelor's degree or beyond, not have a Federal Pell Grant overpayment, not be in default on any Federal Student Loans, have a current (2017-2018) FAFSA with a 0 EFC on file and enrolled in a Pell eligible Program. The financial aid office awards the funds equitably.

**Florida Bright Futures** – provides scholarships based on high school academic achievement and is Florida's largest merit-based scholarship program. To be considered, a student **must submit** a completed Florida Financial Aid Application @ www.floridastudentfinancialaid.org during his/her last year in high school (after December 1 and prior to graduation), be a Florida resident, a U.S. citizen or eligible non-citizen, the student must not owe a repayment or be in default under any state or federal grant, loan, or scholarship program unless satisfactory arrangements to repay have been made. Bright Futures covers \$1.30 to \$1.73 per clock hour based on scholarship awarded (Subject to change based on state legislation). Summer clock hours (June – July) are not covered. Please inform the financial aid office if you have Bright Futures. Our school code is 219.

**Florida Public Post-Secondary Career Education Student Assistance Grant (FSAG-CE)** - This grant is need based and available to Florida residents per State allocation to students entering a program of 450 or more clock hours & must have a current error free (2017-2018) FAFSA on file by end of term drop/add period, be a Florida resident, a U.S. citizen or eligible non-citizen, not have bachelor's degree or beyond and not owe a repayment or be in default under any state or federal grant, loan, or scholarship program unless satisfactory arrangements to repay have been made. Minimum annual award amount is \$200 (Subject to change based on state legislation). The financial aid office awards the funds equitably.

Florida Prepaid College Plan - accepted at 100% for tuition fees only. Florida Prepaid cannot be applied to lab fees, textbooks or other miscellaneous costs. The Florida Prepaid credit hour rate will be used as there is no clock hour rate available. A student must submit a valid Florida prepaid card or have information faxed/emailed to the financial aid office.

<u>Career Source</u> – non-profit organization that provides several assistance programs for funding tuition fees to eligible applicants. The application is available on line @ <u>www.careersourceclm.com</u>. Career Source requires students to have a FAFSA on file to be considered for assistance.

<u>Marion Technical College Financial Aid</u> - a limited number of Marion Technical College financial aid is available for eligible students entering qualifying programs. Marion Technical College financial aid covers only a portion of tuition cost, calculated at a qualifying rate of \$1.50 to \$3.00 per clock hour, dependent upon EFC range & fund availability. Application is available to interested parties. Please contact the financial aid office for information and details of availability, requirements, and eligibility. Marion Technical College financial aid does not have to be repaid (Satisfactory Academic Progress is required). Requires an error free (2017-2018) FAFSA on file to be considered.

<u>Marion Co. High School Student MTC Financial Aid Award</u> - Application is available to interested parties. Please contact the financial aid office for information and details of availability, requirements, and eligibility. Requires an error free (2017-2018) FAFSA on file to be considered.

<u>GED Merit Based MTC Financial Aid Award</u> - Application is available to interested parties. Please contact the financial aid office for information and details of availability, requirements, and eligibility. Requires an error free (2017-2018) FAFSA on file to be considered.

<u>Other Forms of Aid Available</u> - AmeriCorps National Service Organization, Central FL Community Action Agency, Florida Council of the Blind, Florida Council Certified Low Vision, Florida Work Experience Program, Honorably Discharged Graduate Assistance Program, Native American Tribal Scholarships, Rosewood Family Scholarship Fund, Scholarship for Children of Deceased or Disabled Veterans, Veterans Education Benefits (VA) limited program availability and Vocational Rehabilitation (VR).

**Local Organization/Individual Scholarships** – Various Scholarships are awarded for academic excellence, ethnicity, special talents, or the special interest or circumstances of the students. Please inform the financial aid office if you have such an award and information pertaining to the award.

Satisfactory Academic Progress Requirements for Financial Aid Students-Satisfactory academic progress (SAP) for students receiving financial aid include both qualitative and quantitative measurements pursuant with regulation 668.34. Students must maintain attendance rate of at least 90% of scheduled hours/weeks with a minimum of a "C" 70% average or higher as designated by the program in which they are enrolled. The maximum time frame may not exceed 110% of the published length of the program in clock hours and weeks. Students also must be on pace in the program of study as specified by instructor to complete in maximum timeframe. Students SAP will be evaluated regularly & at financial aid check points

Marion Technical College <u>does not accept or participate in any student loans</u>: however a self-certification form can be provided upon request to students who wish to seek a private loan on their own.
